



CONSIGNOR'S AGREEMENT

1. **Right of Acceptance:** Junebug's has the right to accept or not accept any item for consignment. Clothing must be brought in flat and in FRESH ready to sell condition and preferably on hangers or bins (no bags)! Our acceptance is based on what sells and how neatly it is presented. We will not take in clothes older than 1 1/2 years or that have been stored. Our consignment period is 60 days. Toys/Home décor/Furniture items must be clean and in good condition. All toys must have all pieces and batteries. Items for consignment are taken on Wednesdays from 11:00-2:30pm or by appointment if arrangements are needed on a different day. There is a 25 apparel item limit per drop off. Any item not accepted for consignment shall be taken back by the consignor on the same day or such items will be donated to charity. Items that are discovered to be damaged or flawed after the initial inspection/acceptance will be sold at a discount or donated to charity. Please note we do not contact the consignor if this occurs.

2. **Percentages, Pricing, & Fees:** There will be a monthly \$3.75 consignor's fee that will be assessed at the end of each month of your time as a consignor. If the consignor doesn't sell enough to cover the fee, it will be waived. Junebug's sets all prices and we will do our utmost best to determine each item's value, however, we are not responsible to know the market value for all items. We reserve the right to discount merchandise during sale events or coupon promotions, however the price will NOT go under any pre-determined base minimum that was set in this contract. All apparel, toys, accessories, children's/baby equipment (please note so there is no confusion: this includes cribs, toddler beds, children's furniture, crib mattresses, and highchairs) are consigned on a 60/40 (store/consignor) basis. All large pieces of furniture are consigned on a 50/50 (consignor/store) basis. If items are about to go out of a season they will be discounted and then donated as we switch out the displays even if they haven't had the complete 60 days of the full contract (Examples Easter, Christmas.. etc) A buyer's fee, determined by Junebugs, will be applied to the asking price. The purchasing customer, not the consignor, pays for this fee.

3. **Consignor Payments:** Payments are made by check or cash and may be picked up at Junebug's after the 15th of the following month of sale. ***To better accommodate our consignors, please call ahead (2-3 days) so a check can be prepared for you.*** If you would like a check mailed to you, we can for a \$2.50 fee. Please note consignors retain 40% of selling price for check, and they retain 50% of the selling price if they choose store credit. Checks issued for payment that are not cashed within 6 months become null and void. Funds left on your account for more than 12 months without activity are forfeited to Junebug's Consignment.

4. **Contract Terms:** The Consignee agrees to leave merchandise at Junebug's for a minimum of 60 Days. The consignor then has from the 60th day til the 65th to pick up their items that didn't sell. However, if they chose not to pick up on or before the 65th day they will be considered expired merchandise and become property of Junebug's which may be sold or donated. ***(Please note that the consignor is responsible for coming to pick-up their items between the 60th- 65th day and they will be responsible for gathering all their consigned items throughout the store.)*** There will be a \$50 cancellation fee for anyone who picks up their items before the 60 day contract date. Junebug's reserves the right to modify or change the consignment terms and conditions at any time.

5. **Lost/Theft/Damage:** We take every precaution against loss, theft, damage, or shop wear, however, items are consigned at your own risk. Junebug's does not maintain insurance for any other damage and is liable only for making appropriate payment to the consignor for items that actually sell.
